

Tree Violations and Guidelines

- Tree branches overhanging streets are to be maintained so as not to hang lower than fifteen (15) feet above the street.
- Tree branches overhanging a sidewalk are to be maintained to a height no lower than eight (8) feet above the sidewalk.
- Trees, bushes and shrubs that obstruct the public right-of-way or official traffic control devices must be trimmed to maintain good visibility and access at all times.

City-Wide Cleanup Events

- Residents are encouraged to utilize city sanctioned cleanup events to help manage tree limbs or tree waste from their properties.

Hazardous Trees



- Hazardous trees must be removed for the safety of the community.
- Hazardous trees include, but shall not be limited to, dead, dying, diseased or weakened trees, bushes, and shrubs; dead, dying or weakened branches in otherwise healthy trees and shrubs and trees such as are growing wild and without care and maintenance.

Penalties for Violation

The City of Evans seeks to attain voluntary compliance with the municipal code through the administration of a Notice of Violation. When voluntary compliance is not attained, penalties are assessed as follows:

First Violation - \$150

Second Violation - \$500

Third Violation - \$999

Subsequent Violations - \$999

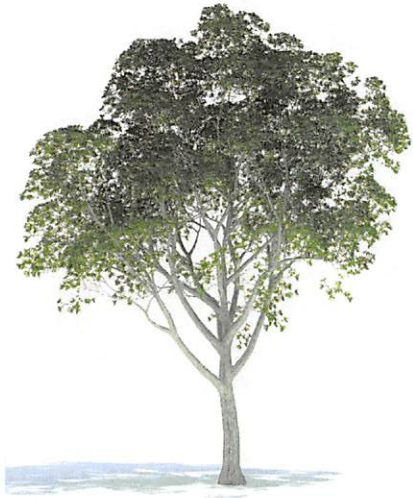
