

Weed Violations and Guidelines



- Noxious weeds are not permitted to grow or remain on any property within the City of Evans.
- Noxious weed identification may be found on the Colorado Department of Agriculture website:
www.colorado.gov/ag/weeds
- In addition to noxious weeds, any useless, troublesome, or injurious vegetation in excess of 12 inches in height is considered a nuisance and may be required to be cut, trimmed, or removed.

Brush Violations and Guidelines



- Brush is not permitted to grow or remain on any property within the City of Evans.
- Brush includes any bush, shrub, or tree that is growing without care.
- In addition, brush includes the cuttings and branches from any bush shrub or tree.
- Branch piles are not to be considered firewood

Penalties for Violation

The City of Evans seeks to attain voluntary compliance with the municipal code through the administration of a Notice of Violation. When voluntary compliance is not attained, penalties are assessed as follows:

First Violation - \$150

Second Violation - \$500

Third Violation - \$999

Subsequent Violations - \$999
